If the results of an election favor a change in boundary, the board of county 13 14 commissioners shall amend its order creating the district to include the change in boundary. The same procedure shall be 15 followed for the removal of any territory from the district. 16 17 The expenses of holding any election shall be paid by the Anastasia Mosquito Control District of St. Johns County. 18 19 Section 4. Chapter 61-2745, Laws of Florida, Chapter 20 73-609, Laws of Florida, Chapter 73-611, Laws of Florida, and Chapter 80-597, Laws of Florida, are hereby repealed 10 days 21 after the effective date of this act; provided the authority 22 23 to levy and assess an ad valorem tax as provided by chapter 388, Florida Statutes, as the same may be amended from time to 24 25 time, shall not be repealed.
